**EXTRACURRICULAR ELIGIBILITY AGREEMENT-SEASONAL ACTIVITIES**

Eligibility will be determined at the regular reporting periods: either quarterly report cards or progress reports. A GPA of 2.0 and no "F" grade is the minimum requirement. At the beginning of each sport, all student athletes are considered on "probation" until the regular quarterly report card or progress report, which comes out during their respective season, is issued. The date this official report is distributed at school is the "cut date". Students who do not meet the minimum requirement are not eligible to participate in practices or events. They are dropped from the team roster.

A student who becomes ineligible for one sport may try out for a future sport. The same eligibility requirements will apply.

**SEE REVERSE FOR IMPORTANT INFORMATION REGARDING TRANSPORTING STUDENTS IN PRIVATE CARS**

Dear Parents:

Anyone transporting a student, other than their own child, from Chaboya to any school-sponsored event must have a copy of their driver's license and proof of liability insurance on file at the District Office. This includes giving students a ride home from an event EVEN IF THEY HAVE A NOTE FROM THEIR PARENTS GIVING PERMISSION! Students riding the bus to an event must ride the bus home unless the person offering them a ride has the proper paperwork on file.

Of course, this does not include the car-pooling if you are leaving the event from your residence (i.e., and event takes place later in the afternoon and the students have been sent home first).

If you are a parent who has given other students a ride to or from sporting events in the past, I urge you to file the proper paperwork with the District Office to avoid any inconvenience.
